

The website of **ROIN WORLD S. L.** uses its own and third-party cookies. A cookie is a file that is downloaded to your computer when you access certain web pages, among other purposes, to ensure the correct functioning of the page, allow the user faster access to selected services, store and retrieve information about the browsing habits of a user or their equipment and even, depending on the information they contain and the way you use your computer, can be used to recognize the user. Cookies are only associated with an anonymous user and their computer or device and do not provide references that allow their personal data to be known, except with their express permission.

The user can, at any time, accept or reject the cookies installed that are not strictly necessary for the correct functioning of the website and the User's access to its services, through the cookies adjustment panel provided on our website. You may also configure your browser at any time without this affecting the User's ability to access the content. However, we inform you that the rejection of cookies may decrease the proper functioning of the web.

### **COOKIES AFFECTED BY THE REGULATIONS AND EXEMPT COOKIES**

According to the EU directive, the cookies that require the user's informed consent are analytical, advertising and affiliation cookies, with the exception of technical cookies and those necessary for the operation of the website or the provision of services expressly requested by the user.

### **TYPES OF COOKIES**

- a) Depending on the **entity that manages them**, there are **own Cookies** (those that are sent to the user's terminal equipment from a computer or domain managed by the editor itself and from which the service requested by the user is provided) and **third-party Cookies** (those that are sent to the user's terminal equipment from a computer or domain that is not managed by the editor, but by another entity that processes the data obtained through the cookies).
- b) Depending on **how long they remain active**, there are **session cookies** (designed to collect and store data while the user accesses a web page) and **persistent cookies** (in which the data is stored in the terminal and can be accessed and processed for a period defined by the party responsible for the cookie, which can range from a few minutes to several years).
- c) Depending on the purpose for which they process the information they collect, they may be:
- **Technical cookies** (necessary for the use of the website and the provision of the contracted service),
  - **Personalization cookies** (which allow the user to access the service with predefined characteristics, such as language, browser type, regional settings, etc.).
  - **Analysis cookies** (collect information on the use made of the website),
  - **Advertising cookies** (collect information about users' preferences and personal choices),
  - **Affiliate cookies** (they allow to track visits from other websites, with which the website establishes an affiliation agreement).

#### What do we use your personal data for?

#### To whom do we disclose your data?

#### What is the period of conservation of your data?

The period of conservation of the data collected is the same as the duration of the cookies used on this website.
